



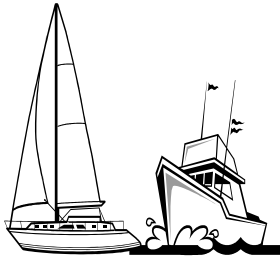

Our membership currently stands at **114 total** broken down as follows: 5 Charter, 51 Regular, 48 Associate, 5 Sustaining, 4 Honorary and 1 Honorary Life Charter.

We gained a total of 29 new members (14 Regular, 12 Associates and 3 Sustaining) for 2003 and lost 16 members (1 charter, 6 regular, 8 associates and 1 Sustaining) for a **net gain of 13 new members** (7 regular, 4 associates and 2 sustaining) over 2002.

Members should be very proud of our financial condition considering we spent approx \$6600 on Club Upgrades and \$1500 on the catered dinner for our annual December election and Christmas Party.
